About Creative Kids

Creative Kids funding is:

- based on a family’s financial need
- open to Saskatchewan residents
- available for children ages 4 to 19
- for activities that are primarily artistic and/or cultural

Creative Kids may provide up to \$750 for a child’s activity. If an application is funded, Creative Kids pays the instructor or service provider directly.

Application dates

We have several application deadlines which change slightly each year. Check the website for a list of current application deadlines.

Mailed applications must be received by the deadline date.

You will be notified of results within 30 days of an application deadline.
